### 1. QUALIFICATIONS/INITIAL REQUIREMENTS FOR ADMISSION: (DO NOT APPLY if you are NOT QUALIFIED)

- Must be a natural-born citizen of the Philippines.
- Person of good moral character.
- Male or Female, and with no parental obligation.
- Must be already in uniformed service with the Bureau of Fire Protection (BFP) and Bureau of Jail Management and Penology (BJMP).
- At least two (2) years in service and not more than 28 years of age on the day of the appointment.
- Weight not more or less than five (5) kilograms from the standard weight corresponding to his/her height, age, and sex.
- No pending case prior to his/her appointment as FO1/JO1.
- Not convicted for an offense or crime involving moral turpitude.

### 2. GROUNDS FOR MEDICAL DISQUALIFICATIONS:

- Defective Visual Perception (color blindness, near sighted/far-sighted with corrective eyeglasses or lens, nystagmus)
- Physical deformities example: bowlegged or congenital defects;
- Perforated eardrum, chronic sinusitis, bleeding tendencies, hemorrhoids, hernia (if not treated), varicocele, extensive skin disorders.
- History of heart disease, hypertension, asthma, active PTB, kidney, and liver diseases, epileptic seizure disorders, major operations; communicable diseases.
- Full dentures, upper and lower, Cleft lip and palate, Malocclusion, Deformities of the face, Open bite, Tongue-tied, missing of four (4) anterior or front teeth, and missing of six (6) posterior/molar teeth.
- Tattoos and other brotherhood marks on skin, ear piercing (for male only).
- For females: History of pregnancy; Painful menstruation.
- Any other similar defects which may hinder in the Cadetship Training Program.

3. The **PHILIPPINE PUBLIC SAFETY ACADEMY (PPSA) Cadetship Program** is a government scholarship program. Admitted cadets must complete the Cadetship Program and serve the government either in the BFP or BJMP services subject to their completed degree (Bachelor of Science in Fire Protection Administration - BSFPA or Bachelor of Science in Penology and Corrections Administration - BSPCA). A cadet who voluntarily resigns or is separated for cause shall reimburse the academy all the expenses incurred during the duration of his/her training. In this regard, the academy shall forfeit any emoluments accruing to the cadets at the time of his resignation or separation.
